



Shipping Instructions

For the Return of Self-Luminous Exit Signs

Apply the pre-paid UPS shipping labels, supplied by TritiumDisposal.com, to the outside of each box. Do not cover the barcode portion of the label with shipping tape.

Do not ship any signs to our corporate office in Columbus, OH.

Complete and return the <u>Shipping Checklist</u> (pg 2) to TritiumDisposal.com. Failure to return this checklist before the shipment arrives to our facility may result in the shipment being refused at its destination and returned to sender at the shipper's expense.

Complete and mail the <u>Transfer Notification Letter</u> (pg 3) within 30 days of your shipment.
